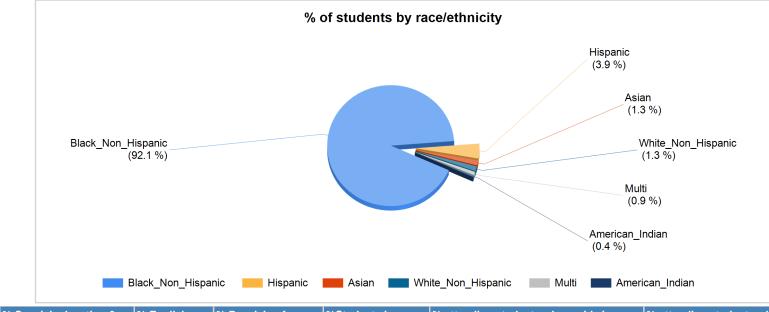
#### Mission Statement as of May 2013

As a school, we will start with mathematics because this is lowest area consistently across scores.	We currently look at ISAT and EXPLORE data but with no particular method. There is a need to create a system to look and analyze data that will shift instruction to benefit the students.
Develop a school wide system to create consistent norms and consequences for student behavior.	Our current use of an internal system is not consistant among teachers. The number of suspensions are down in Verify, but for Student Code of Conduct codes 1 and 2 the discipline in not consistant among students.
