
Mission Statement as of May 2013

Schoolwide integration of writing across the curriculum.	The CCSS note that in order to build a foundation for college and career readiness, "students must devote significant time and effort to writing, producing numerous pieces over short and extended time frames throughout the year", thus students must be prepared to meet the rigor of Common Core Standards for college/career readiness.
Teachers will increase exposure and emphasis on Algebraic skills and concepts schoolwide.	Based on Winter 2011-2012 NWEA data 57.1% if our students scored in the "Low" (34.4%) or "Low/Average" (22.7%) category for Algebra. In order to prepare our students to be "algebra proficient", as required under the CCSS, we must increase our students' understanding of algebraic concepts and skills necessary for success in secondary and post-secondary education.
